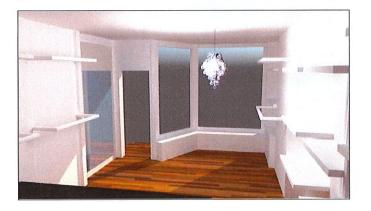

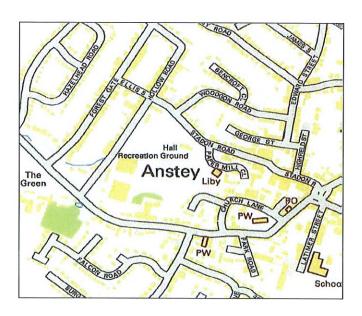

The premises are believed to be connected to mains electricity, water and drainage. Mains gas is available for connection.

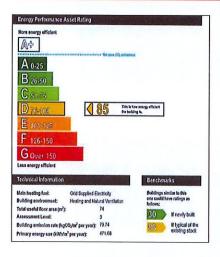
