LOCATION

Union Wharf is the terminus of the Market Harborough arm of the Grand Union Canal. It is located approximately half a mile to the north of Market Harborough town centre on the west side of Leicester Road, less than two miles to the south of its junction with the A6 bypass. The latter runs to the east of the town linking with the A14 to the south.

Market Harborough is an attractive market town, strategically served by East Midlands Trains' London St Pancras International service.

DESCRIPTION

Unit 2 comprises one of a terrace of four similar properties standing on the north side of the extended canal basin and forms part of Canal & River Trust mixed use development, which includes private housing, restaurant, offices and studios.

This is a modern, purpose built studio with fitted kitchenette, disabled toilet, extensive double glazed frontage, Velux roof lights in rear roof elevation.

There is a service charge covering maintenance of the fabric of the studio and the common parts of the estate.


